

- 10.4. The scope of the works includes the disposal of the cut trees as per the local authority/ forest guidelines & site clearance.
  - 10.5. Cut trees shall be the property of the successful bidder. The arrangement of transportation and disposal shall be the responsibility of successful bidder/ Contractor.

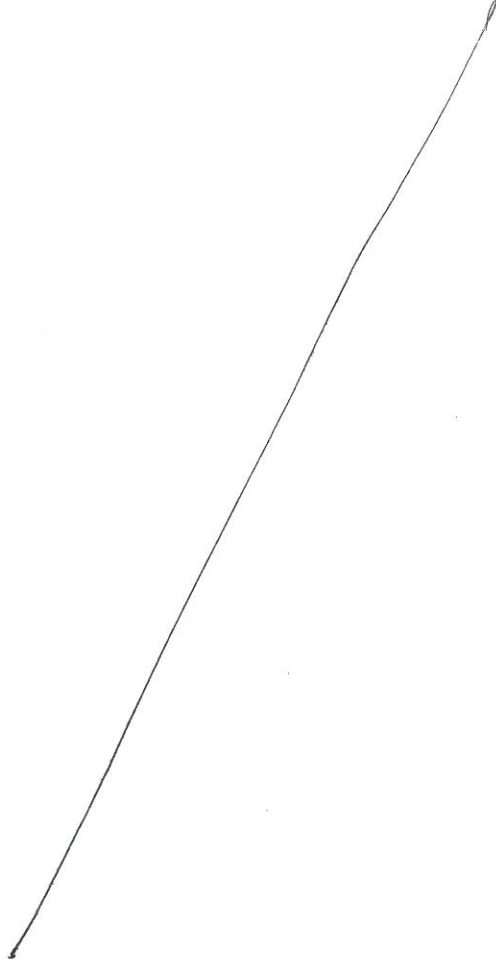

- 1.1.6. **Year** means 365 days
- 1.1.7. **Commencement date:** The date mentioned in the Letter of acceptance or the date mentioned in the separate notice for the commencement of work as per Clause 4.1.
- 1.1.8. **Accepted Contract Price:** means the amount accepted in the Letter of Acceptance for the design, execution and completion of the Works and the remedying of any defects.
- 1.1.9. **Laws:** means all national (of state) legislation, statutes, ordinances and other laws, and regulations and by-laws of any legally constituted public authority.
- 1.1.10. **Time for the Completion:** as defined in the Sub-Clause 4.2 of these contract conditions.

##### 1.2. Interpretation

In the Contract, except where the context requires otherwise:

- 1.2.1. words indicating one gender include all genders;

Personnel, Goods, consumables and other things and services, whether of a temporary or permanent nature, required in and for the execution of work.

- 3.1.4. It is deemed that the Contractor has inspected the proposed site of work and acquaint/ themselves with the site conditions, working hours, layout of trees, approach road, pathways available, etc. and all relevant items connected with the execution of work. No claim shall be entertained for the contractor(s) making his/their own arrangements for approaches/ approach road from outside site and contractor(s) will bear entire expenses such as road taxes, payment for right of way etc. to outsiders and for construction of approaches/approach roads etc.

**3.2. Performance security**



- 3.2.3.4. A Performance Security from Co-operative Banks shall not be acceptable, in any manner or form.

3.9.1. The Contractor shall make his own arrangements for the engagement of staff and labour at his own cost.

3.9.2. The Contractor shall be responsible to ensure compliance with the provision of the Minimum Wages Act, 1948 (hereinafter referred to as the "said Act" in this Sub Cl. 3.8) and the Rules made thereunder in respect of any employees directly or through petty contractors or subcontractors employed by him.

3.9.3. If, in compliance with the terms of the contract, the Contractor supplied any labour to be used wholly or partly under the direct orders and control of the NHSRCL whether in connection with any work being executed by the Contractor or otherwise for the purpose of the NHSRCL such labour shall, for the purpose of this Clause, still be deemed to be persons employed by the Contractor.

3.9.4. If any moneys shall, as a result of any claim or application made under the said Act be directed to be paid by the NHSRCL, such money shall be deemed to be moneys payable to the NHSRCL by the Contractor and on failure by the Contractor to repay the NHSRCL any moneys paid by it as aforesaid within seven days after the same shall have been demanded, the NHSRCL shall be entitled to recover the same from any moneys due or accruing to the contractor under this or any other Contract with the NHSRCL.

**3.10. Contractor's responsibility to arrange**

3.10.1. The contractor should make their own arrangements for all plants and tools required for the successful completion of the work in time.

#### 4. Commencement, Delays and Suspension

##### 4.1. Commencement of Works

## **8. Force Majeure**
