### 1.0 GENERAL

#### 1.1 Name of Work:

National High Speed Rail Corporation Ltd. (NHSRCL) invites online open etenders from eligible applicants, who fulfil qualification criteria as stipulated in Clause 2.12.1 of ITT, for the work Appointment of Agency for Communication Management and Facilitation in Land Acquisition in connection with Land Acquisition for Mumbai - Ahmedabad High Speed Rail Project in Palghar District.

The brief scope of the work is provided in Employer's Requirement.



#### 2 INTRODUCTION

### 2.1 Background

NHSRCL (the "Employer") is implementing 508 Km long Mumbai-Ahmedabad High Speed Rail Project (hereinafter called as MAHSR Project) starting from Bandra Kurla Complex in Maharashtra and terminating at Sabarmati in Gujarat.

For supervision of project works, five site offices have been established at Mumbai, Palghar, Vadodara Surat and Ahmedabad headed by Chief Project Manager (CPM).

NHSRCL intends to appoint an agency for Communication Management and Facilitation in Land Acquisition for Palghar district which is having length of 108 KM of MAHSR to handle communication with various stakeholders like land owners, government officials, people's representatives, opinion makers, media, etc. which need to be communicated properly about the project on a regular basis.

The Agency/Consultant shall perform the activities in accordance with the Terms of Reference (the "TOR")

# 2.2 Request for Proposals

NHSRCL invites proposals (the "Proposals") for selection of Communication Planning and Public Relations Management Agency (hereinafter referred as the "Agency" or "Consultant") for scope of services in conformity with the TOR (collectively the "Consultancy").

NHSRCL intends to select the Agency through an open competitive bidding process in accordance with the procedure set out herein.

# 2.3 **Due diligence by Bidders**


Bidders are encouraged to inform themselves fully about the assignment and the local conditions before submitting the Proposal and have site visit, sending written queries to the NHSRCL, and attending a Pre-bid Meeting on the date and time specified in Clause 1, NIT.

#### 2.4 Sale of Tender Document

Tender document can be purchased from the NHSRCL office at the address mentioned from Date 07.02.2023 09:00 hrs to Date 02.03.2023 hrs 13.00 Hrs. Bidding documents can also be downloaded from website <a href="http://www.nhsrcl.in">http://www.nhsrcl.in</a>. and from Govt e-procurement portal (CPP) viz, <a href="https://etenders.gov.in/eprocure/app.">https://etenders.gov.in/eprocure/app.</a>.

### 2.5 Validity of the Proposal

The Proposal shall be valid for a period of not less than 90 days from the date of submission of tender.



# 2.6 Brief description of the Selection Process

The Employer has adopted a two stage selection process (collectively the "Selection Process") for evaluating the Proposals comprising of technical bids and financial bids to be submitted online by the Applicant. The selection will be done through QCBS (Quality and Cost Based Selection) process with 70% weightages to technical proposal and 30% weightages to financial proposal. In the first stage, a technical evaluation will be carried out. Based on this technical evaluation, a list of short-listed applicants shall be prepared. In the second stage, a financial evaluation will be carried out. Proposals will finally be ranked according to their combined technical and financial scores. The first ranked Applicant (the "Selected Applicant") shall be called for negotiation, if necessary.

# 2.7 **Pre-Bid Meeting**

The date, time and venue of Pre-Bid Meeting shall be:

Venue: Online Meeting

An online Pre-Bid meeting through Video Conferencing to clarify bidder's issues will be held as per details given in Notice Inviting Tender. Interested eligible Bidders, who have either purchased the Bidding Documents beforehand or the bidders eligible for exemption of tender document cost (as per tender conditions like MSME, Startup India), will be invited to attend the meeting, provided bidder submits a request along with the proof of payment of tender document cost submission/Credential for tender document cost exemption as above, through email at cpmpalghar@nhsrcl.in by NIT's Pre bid Meeting date up to 11:00 hrs. Login credentials shall be provided to interested eligible Bidders through email.

The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.


The tenderer is requested to submit any question in writing through e-tender portal only (no query will be considered if received other than e-procurement portal), to reach the Employer not later than the last date of seeking clarification as mentioned in key details of NIT.

The text of the questions raised by all the tenderer and the responses given will be transmitted through e-tender portal within date specified in NIT. Any modification of the Tender Documents which may become necessary as a result of the Pre-Bid meeting shall be made by the Employer exclusively through the issue of an Addendum.

Non-attendance at the Pre-Tender meeting will not be a cause for disqualification of a Tenderer.

#### 2.8 **Pre-Proposal visit to the Site**

Bidders are advised to visit the site and collect necessary information from site prior to submission of the tender. For this purpose, they will provide at least two days' notice to the Engineer in Charge.

## 2.10. A. Public Procurement Policy for Micro and Small Enterprises (MSEs):

- a) Procurement Preference to Micro and Small Enterprises (MSEs) as admissible under Government's existing policy on the date of opening of bid shall be applicable to Micro and Small Enterprises (MSEs) registered with any statutory bodies specified by Ministry of Micro, Small & Medium Enterprises having Udyog Aadhaar Memoranda shall also be given all benefits under Public Procurement Policy Order 2012.
- b) The bidders shall submit photocopy of current and valid MSEs registration certificate inclusive of all the pages showing the category of entrepreneur whether the registered firm is owned by General or SC/ST entrepreneurs, monetary limit of their registration for the items tendered to avail the benefits under the policy. The MSEs shall also submit a copy of "Entrepreneur's Memorandum (Part II)" of the concerned District Centre where the unit is established. The MSEs must also indicate the terminal validity date of them registration.
- c) Such MSE registered firms shall be exempted from payment of Tender document cost and payment of Tender Security.
- d) Definition of MSEs owned by SC/ST is as given below:
  - i. In case of proprietary MSE, proprietor(s) shall be SC/ST.
  - ii. In case of partnership MSE, the SC/ST partners shall be holding at least 51% shares in the unit.
  - iii. In case of Private Limited Companies, at least 51% share shall be held by SC/ST promoters.
- e) All bidders registered under Micro and Small Enterprises (MSEs) shall have to satisfy the eligibility criteria at par with other bidders. There shall not be any relaxation in eligibility criteria/bidding process or other bid requirement and L1 price.
- f) If lowest valid bidder is non-MSE firm, then in such a case purchase preference facility shall not be applicable in the bid as quantity cannot be split. The total quantity shall be offered to the lowest valid bidder irrespective of their registration status and the benefit to MSEs shall be limited to exemption from cost of tender document and tender security only.
- g) The above facilities shall not be applicable for the items for which they are not registered.
- h) The above facility shall be applicable only in case of single entity or all member in JV/Consortium are registered and eligible MSEs.

#### B. Startup India:

a) All Startups (whether Micro & Small Enterprises or otherwise) are exempted from



cost of Tender document and Tender security.

b) Definition of Startup: Startup means an entity recognised as Startup by Department of Industrial Policy and Promotions (DIPP), Ministry of Commerce and Industries, Govt. of India.

c) The above facility shall be applicable only in case of single entity or all member in JV/Consortium are registered and eligible Startups.
