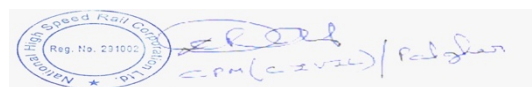

3.4 All the vehicles deployed shall comply with all the rules and regulations, stipulations enforced from time to time by transport authorities (RTO) and other government, local, statutory bodies. In case of any violations the penalty/charges incurred will be the liability of the contractor and nothing extra shall be payable.

3.5 The tentative date for deployment of all the vehicles will be as per LOA. Actual number of vehicles to be deployed will be decided by Officer in-charge, however contractor will have to make sure the availability of vehicle within 5 days, as & when required by the OIC.

3.6 All the vehicles to be provided by the successful bidder should be in good condition and should be mechanically sound. The vehicle will have to be fitted/provided with decent interiors including Air conditioner, Clean seat covers, Quality radio music system, Reading lamp, Tissue paper box, Car perfume, Mobile charger, Seat Belts (Front & Rear), First Aid Box, and Umbrella during Monsoon. Vehicle should be in perfectly sound working condition and suitable for use by Senior Officers. Tenderer should note that above mentioned list is only indicative and not exhaustive. No extra cost shall be paid for the same.

3.7 Vehicle will be required generally for 12 hours every day. Vehicle shall be required for full calendar month including Saturdays and Holidays. Vehicles are to be provided for 26 days in a month. Maintenance rest will be provided normally on Sundays. In case of exigencies and emergencies, the vehicle can be called on Sundays also. Contractor will however provide suitable substitute driver for
